- 6. Warranted that Driver for Commercial/heavy motorized Vehicles /Class D category vehicles as per IMT are not covered under the policy.
- 7. Warranted that armed security guards & fire fighters are not covered under the policy.
- 8. Warranted that all the employees belong to Risk category I & II only

Addition & deletion process:-
